TerraTrove MT-17 is a soil amendment designed to aid in the conversion of organic fertilizers into plant available forms and is ideal for application with bulk inputs such as manure, compost and green manures. Application of TerraTrove<sup>™</sup> MT-17 increases microbial populations in the rhizosphere and contains humic substances to help improve soil characteristics.

## **Mixing and Application:**

Shake well before using. Tank mix TerraTrove MT-17 according to the directions in the table below. Mix only enough for the immediate application. Do not mix product with bactericides or copper compounds. Only mix TerraTrove MT-17 with other products the day of use.

#### Storage & Disposal:

**Storage:** TerraTrove MT-17 should be stored in original container, away from heat and direct sunlight. Preferably store in cool areas out of direct sunlight, away from children and pets, feed, and food products. **DO NOT ALLOW TO FREEZE**. Do not contaminate water, food, or feed by storage, disposal, or cleaning of equipment.

**Disposal:** Do not reuse this container. Rinse with water and add rinsate to spray tank, then offer container for recycling or by reconditioning, or puncture and dispose of in a sanitary landfill or incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.

Product guaranteed effective up to 1 year after date stamped on container.
